Dear Judge Furman:

Pursuant to the Court's Endorsement Order dated August 9, 2024 (Dkt. # 637), Zimmer and Plaintiffs Amy Krishkha (Case No. 23-CV-6232), Carol Dunn (Case No. 24-CV-540), and Joan James (Case No. 24-CV-327) (collectively, the "Parties")¹ write to provide the Court with an update on the *Krishka*, *Dunn*, and *James* cases.

1. Amy Krishka v. Zimmer, Inc. et al., 23-CV-6232

Zimmer and Plaintiff Amy Krishka continue to discuss settlement informally and respectfully request an additional 60 days to continue settlement discussions before any additional deadlines are put in place for the *Krishka* case.

2. Joan James v. Zimmer, Inc. et al., 24-CV-327

Zimmer and Plaintiff Joan James have agreed to settle the *James* case and are in the process of executing the final settlement paperwork. Zimmer and Ms. James will file a stipulation of dismissal once the settlement is final.

3. Carol Dunn v. Zimmer, Inc et al., 24-CV-540

Zimmer and Plaintiff Carol Dunn have agreed to settle the *Dunn* case and are in the process of executing the final settlement paperwork. Zimmer and Ms. James will file a stipulation of dismissal once the settlement is final.
